ADMISSION RULES & REQUIREMENTS

12 August 2006: last update

- -1- The moral and practical life of the students are the responsibility of the Principal and Educators of DUZ, and they have an obligation to enforce the CODE OF CONDUCT.
- -2- Students who live in the DUZ living quarters are not permitted to leave the campus without written permission. Permission will be granted by the DEPUTY PRINCIPAL'S sole discresion.
- -3- All academic and other concerns of a student must be discussed with the Principal by appointment.
- -4- The allocation of rooms and beds are determined by DUZ administration.
- -5- Rules pertaining to rooms and bed must be adhered to Refer to Living Quarters Rules & Regulations.
- -6- Cellphones are not allowed under any circumstances.
- -7- Electronic equipment is not allowed.
- -8- Punctuality of classes is an important aspect of the students academic calendar and no deviation from the timetable is allowed.
- -9- Punctuality for Salaah forms a cornerstone of the students obligations and they must be punctual in this FARD.
- **-10-** The Principal and Vice Principal are at liberty to conduct an inspection on a students personal belongings as a controlled method or as a checking tool.
- -11- The dress code of DUZ is strictly Islamic. students must wear a long white Kurta and Izzar (this must be above the ankles).
- -12- The students hair must be short and presentable.
- -13- Clothing with bold inscriptions is not allowed.
- -14- The student must safeguard the property and equipment of the DUZ.
- -15- Water & Electricity must be treated as a trust and used sparingly.
- -16- Intoxicants, contraband & any form of pornography are not allowed.
- -17- Misconduct is treated as a serious offence Refer to Category of mis-conduct.
- -18- Affiliation to student bodies or unions are not allowed.
- -19- students are expected to attend classes for the duration of the academic year.
- -20- Examinations are compulsory.
- -21 The annual fee is payable on statement.
- -22- A deposit may be asked due to any unforeseen costs arising from the application.
- -23- Parents must indicate clearly their payment options.
- -24- In the event of zakaat being used, the prescribed documentation must be produced and filled in.
- -25- Foreign students are required to produce a security clearance.

LIVING QUARTERS RULES & REGULATIONS

12 August 2006: last update

- -1- The living quarters are the property of the DUZ.
- -2- The DUZ have employed supervisors for the upkeep of the property and to regulate this document, it is therefore imperative that all rules and regulations in this document are adhered to.
- -3- Rooms and beds are determined by the DUZ Administration.
- -4- The waking up and sleeping times are determined by the supervisors and students will be advised.
- -5- All gates are closed TEN(10) minutes before Salaah.
- -6- No cooking is allowed in the room.
- -7- students eating in the room must clean up after themselves and ensure the cleanliness and tidiness of their rooms.
- -8- The Ameer of the room must ensure the smooth control of the room and is responsible for any mis-demeanors.
- -9- Breakages and misuse of DUZ property is to be reported to the supervisors.
- -10- students in their rooms, due to illness, while class is in session must have written permission from the Vice Principal.
- -11- Room inspections will be conducted by the management of DUZ at regular intervals.
- -12- Students are not allowed in their rooms while class is in session
